### 1. Pre-sub Events 3 days 5, 6 & 7<sup>th</sup> October

An annotated autumn 2016 Leaflet found during the consultation in the Baptist Church was discussed. It was generally agreed that the comments were not new and the leaflet had been mixed in with spare leaflets left out for the public to look at. The comments were noted but it was agreed not to take them further.

- **1c.** the possibility of having short presentations/road shows at Rowney Green and Hopwood was discussed.

Venues of The Goat and Trousers at Rowney Green and Hopwood Village Hall were suggested. Friday nights at the Rowney Green Village Hall was preferred with evenings of 27 October and 3 November suggested, the latter was the preferred date.

Dorothy and Adrian agreed to contact the Rowney Green Village Hall Committee to check availability of the venue.

The day following the Rowney Green consultation is to be explored for Hopwood.
