Conclusion: There is some support for increasing local business even in small settlements however there is no agreement that any green belt land should be used. Rowney Green residents who commented do not support pedestrianisation in Alvechurch. **Some Lounge customers are more positive about business development generally, especially in rural settlements, but results show a spread. They are very interested in the suggested pedestrianisation/ development of the centre of Alvechurch Village.** The Baptist Church group had similar responses to the Lounge, except they were more against giving up any green belt land for business.

There were several “unattached” comments on this section. One says that it is a done deal that Redditch will expand into the sites adjacent to the A441 in exchange for building the Bordesley bypass (not the case)

There is one separate comment saying that house building in Alvechurch is spoiling the traditional aura of the village, especially affordable housing and the people who live there. Another says the national housing shortage needs action.

Several participants at the Baptist Church sessions stressed the need for housing for the elderly, as did some in discussion at APM.

Conclusion

Many people do not accept the premise that some green belt land may have to be released and just repeat that it should be preserved. Some do not realise we don't have brown field sites. However, there is some indication that limited development around settlements may be acceptable. There is strong support for this to be small inexpensive houses (except at Hopwood!). There were comments in some sessions about housing for the elderly,

There was one pair of options that we have not communicated clearly. These were that:

2. Further parish growth should be apportioned equally across the settlements on limited green belt sites

3. Greenbelt land released for future need should be mainly round the edges of Alvechurch village
Several respondents ticked both of these, whereas they are really mutually exclusive. These responses need to be treated with caution.

The general antagonism to using green belt, and the confusion about the two options above, means that neither option 2 nor 3 has a majority in favour, despite there being a good majority for option 1.

The Lounge customers have a wide spread of views about housing, but many support building small houses. The Baptist Church ones are similar, and specifically mention housing for the elderly.

A separate comment is concerned that it is a done deal that Redditch will expand into the sites adjacent to the A441 in exchange for building the Bordesley bypass.

There is one separate comment saying that house building in Alvechurch is spoiling the traditional aura of the village, especially affordable housing and the people who live there. Another says the national housing shortage needs action.

Several participants at the Baptist Church sessions stressed the need for housing for the elderly

Conclusion: All the responses in this section show a majority in agreement. There is overwhelming support for keeping the countryside wildlife-friendly, with a high proportion “strongly agreeing”, though some people confuse this with green belt. Generally people support farming and other appropriate use, improving access to the countryside, and more use of green technology and energy conservation. Where people are not in favour they have tended to not disagree either but remain neutral. There is such a generally positive response that it may be an issue which options are preferred when there is a clash of uses, for example between wildlife and leisure use, or farming and access. The answers from the Lounge are more mixed, though more positive about disability access. Most support more use of green technology and using the countryside productively.

The Baptist Church responses are similar, but with stronger support for using the countryside productively, and there is not quite such overwhelming support for wildlife.

Conclusion: There is some confusion about what traffic management means, but people are concerned about speeding both through Rowney and on the main road. There is strong support for improving public transport: more than the one daily bus and better connections with the train service. Generally better footpaths and support for cyclists are supported. Car parking in Alvechurch is not a big issue but there is some comment about bad enforcement of existing restrictions.

There is one separate comment about the state of verges round the village, especially Lower Rowney Green, Gravel Pit Lane, making it difficult to walk around the lanes.

General conclusion

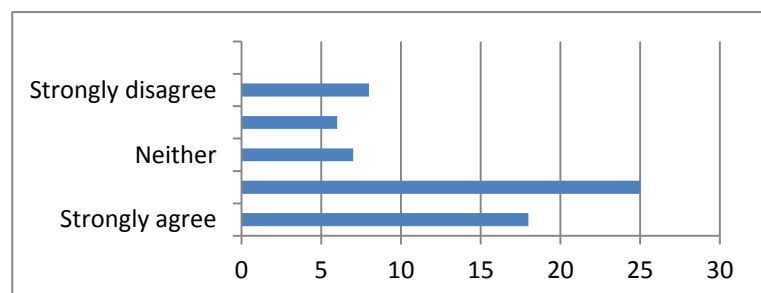

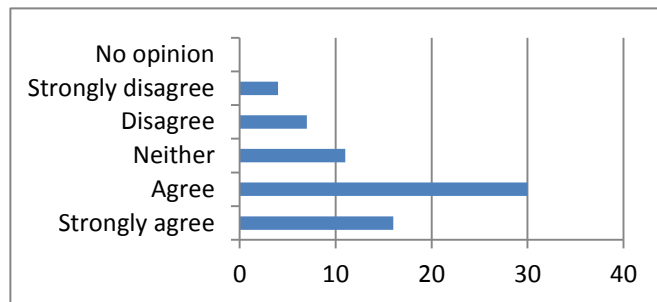

Summaries of the Results

BUSINESS AND JOBS

Conclusion:

There is some support for increasing local business even in small settlements however there is no agreement that any green belt land should be used. Rowney Green residents who commented do not support pedestrianisation in Alvechurch. **Some Lounge customers are more positive about business development generally, especially in rural settlements, but results show a spread. They are very interested in the suggested pedestrianisation/ development of the centre of Alvechurch Village.** **The Baptist Church group had similar responses to the Lounge, except they were more against giving up any green belt land for business.**

HOUSING

There were several “unattached” comments on this section. One says that it is a done deal that Redditch will expand into the sites adjacent to the A441 in exchange for building the Bordesley bypass (not the case) There is one separate comment saying that house building in Alvechurch is spoiling the traditional aura of the village, especially affordable housing and the people who live there. Another says the national housing shortage needs action.

Several participants at the Baptist Church sessions stressed the need for housing for the elderly, as did some in discussion at APM.

Conclusion

Many people do not accept the premise that some green belt land may have to be released and just repeat that it should be preserved. Some do not realise we don't have brown field sites. However, there is some indication that limited development around settlements may be acceptable. There is strong support for this to be small inexpensive houses (except at Hopwood!). There were comments in some sessions about housing for the elderly,

There was one pair of options that we have not communicated clearly. These were that:

2. Further parish growth should be apportioned equally across the settlements on limited green belt sites

3. Greenbelt land released for future need should be mainly round the edges of Alvechurch village
Several respondents ticked both of these, whereas they are really mutually exclusive. These responses need to be treated with caution.

The general antagonism to using green belt, and the confusion about the two options above, means that neither option 2 nor 3 has a majority in favour, despite there being a good majority for option 1.

The Lounge customers have a wide spread of views about housing, but many support building small houses. The Baptist Church ones are similar, and specifically mention housing for the elderly.

A separate comment is concerned that it is a done deal that Redditch will expand into the sites adjacent to the A441 in exchange for building the Bordesley bypass.

There is one separate comment saying that house building in Alvechurch is spoiling the traditional aura of the village, especially affordable housing and the people who live there. Another says the national housing shortage needs action.

Countryside environment

Conclusion:

All the responses in this section show a majority in agreement. There is overwhelming support for keeping the countryside wildlife-friendly, with a high proportion “strongly agreeing”, though some people confuse this with green belt. Generally people support farming and other appropriate use, improving access to the countryside, and more use of green technology and energy conservation. Where people are not in favour they have tended to not disagree either but remain neutral. There is such a generally positive response that it may be an issue which options are preferred when there is a clash of uses, for example between wildlife and leisure use, or farming and access. The answers from the Lounge are more mixed, though more positive about disability access. Most support more use of green technology and using the countryside productively.

The Baptist Church responses are similar, but with stronger support for using the countryside productively, and there is not quite such overwhelming support for wildlife.
